Dear Parishioners

Our Parish's accounts for the year ended 31 December 2021

As we all remember, Tier 4 COVID 19 restrictions were in place for Masses for 55% of 2021. Whilst less severe than in 2020, this again impacted on the spiritual life of our Parish, as well as having a negative impact on our finances. I hope that the various headings and amounts in the accounts are self-explanatory, but would like to mention six items in particular:

- Offertory Envelopes and Offertory Loose Plate donations fell by £2,154 and £560 respectively in 2021, whilst donations by Standing Orders increased by £4,918 compared to 2020; an overall increase in Offertory Income of £2,203 or 6%;
- Christmas/Easter Offerings, Stipends and Fees increased by £3,311 (177%) compared to 2020;
- we received a tax repayment of £4,563 in 2021 from HM Revenue & Customs in respect of our main Gift Aid claim for the tax year 2019/20. Gift Aid is a valuable source of income and I would ask that all Parishioners who are able consider giving under Gift Aid;
- the cost of heat, light and water decreased by £2,056 compared to 2020. Included in this figure is a reduction of £2,297 for the cost of gas, as the church was being heated too often in 2020 because the timer was set incorrectly.;
- the Diocesan Assessment, based on our Assessable Income for 2019, increased by £3,882 (50%) in 2021 compared to 2020; and
- although we restricted expenditure again in 2021 by dealing only to the most pressing matters, the age of the Church and Presbytery means that the cost of repairs and renewals will increase as we return to normal.

I am grateful for the time and donations given by Parishioners in 2021. I am all too aware of the current steep increases in the cost of living and how this impacts on individuals and our Parish. Please continue to support our Parish through such donations as you can afford, offering your time where possible and through your prayers.

If you have any questions about the accounts, please speak to me. If I do not know the answer, I will find it for you.
