## **Suspension of Public Services**

*As earlier in the year, the Government has suspended public worship in our churches. This time round we have at least the ability to live stream the Masses which will be said in church, but without a congregation.*

*Although the legislation allows for churches to be open for private prayer, we have found recently a challenge in getting regular stewards to cover the times of opening – and for quite a small number of people coming to pray – as well as the effort and expense of de-sanitizing the church after each session.*

*Since we have now the live streaming option the church will be closed, except for private prayer on Saturday and Sunday from 10am – 12 noon.*

## **Christmas 2020**

*How this is going to be able to be celebrated in the church, if at all, depends on the directions the Government puts in place after December 2<sup>nd</sup>. It raises some issues to be thought about.*

*If public Masses are allowed to resume, how do we accommodate those who would attend at Christmas. If congregational singing is still prohibited should we have Mass at Midnight? The pressure on space has some way to be managed. In the light of this, at this stage, one cannot predict what the Christmas services schedule will be. We hope that the December 2<sup>nd</sup> "moment" will allow us to plan for some sort of Christmas in church.*
